General Terms and Conditions applicable to this Offer made by North American Concrete and to the agreement formed by its acceptance by Owner. (Version: April 26, 2017)

COMMERCIAL GENERAL CONDITIONS		
1	Acceptance Period	The Offer is subject to revision or withdrawal if not accepted within 30 days.
2	Permits	Unless otherwise stated in the Offer, the cost of permits is not included in the Offer.
3	Bonding	Unless otherwise stated in the Offer, the cost of bonds is not included in the Offer.
4	H.S.T.	H.S.T. is not included in the Contract Price stated in the Offer.
5	Priority of Documents	The Offer Letter accompanying these General Conditions shall have priority over all other contract documents, to the extent of any conflicts.
6	Standard Unit Rates	Standard Unit Rates (SUR) for payment to North American Concrete for all extra work and standby time shall be the rates for equipment, labour, and materials set out by North American Concrete in its current Unit Pricing Schedule and which are hereby incorporated into the agreement between North American Concrete and the Client.
7	Terms of Payment & Progress Payments	Where work extends beyond 30 days, North American Concrete shall be entitled to progress payments on account of the contract price, subject to the statutory holdback amount of 10%. Progress payments are payable monthly in amounts that are either (i) proportionate to the work completed, (ii) reflect the time and materials expended, or (iii) are otherwise agreed to in advance on a Schedule to these General Conditions.
8	Work Schedule	Unless otherwise stated in the Offer, the Contract Price is based on: (A) One (1) mobilization by North American Concrete; (B) satisfactory access to the work site to permit North American Concrete to complete the work; and, (C) readiness of the site for North American Concrete's work to enable it once mobilized, to work continuously and without interruption and to complete its work based on the sequence of operations determined by it, failing which the Client shall pay for North American Concrete's additional expenses at Standard Unit Rates.
9	Hours of Work	Unless otherwise stated in the Offer, the Contract Price is based upon the performance of North American Concrete's work using only day shift labour, charged at normal straight time hours of work, in accordance with its collective agreements.
10	Delays	North American Concrete is not responsible for delays due to strikes, fire, flood, accident or other causes beyond control. For delays caused by the Client, the Client shall pay North American Concrete for its additional expenses as extra work and/or demobilization and remobilization costs at Standard Unit Rates as set out in its Unit Pricing Schedule.



11	Extra Work	All work not clearly identified as North American Concrete's work in this Offer is extra work for which the Client shall pay at North American Concrete's Standard Unit Rates. The Client shall review and confirm the accuracy of North American Concrete's work records daily.
12	Salvage, Storage, Transportation	Unless otherwise excluded in the Offer, North American Concrete shall have full legal title to, and exclusive beneficial interest in, all building materials, equipment, and by-products of demolition ("salvage material") from the property, which shall include the right to dismantle, remove, and sell such salvage material, and to retain all proceeds of sale or other disposition. Responsibility, title, and all interest in salvage material pass to North American Concrete when such material ceases to be permanently installed or affixed to the real or immovable property. Storage and transportation of salvage material for the benefit of any party other than North American Concrete is not included in the Offer. If salvage title does not pass to North American Concrete, Client hereby acknowledges and accepts North American Concrete's right to non-possessory lien over salvage until paid in full.
13	Insurance	North American Concrete carries \$5,000,000 in liability and property damage insurance. Any insurance policy issued to North American Concrete in which others are named as additional insureds, is effective only with respect to liability arising out of North American Concrete's negligence.
14	Assignment	Where the project is related to loss or damage covered by insurance and you (Client) are the insured person, by signing the Offer, you assign to us the proceeds of any claim made on that insurance. You authorize us to submit our invoices directly to the insurer for payment provided that you will remain responsible to the extent that there is any balance of our account (including H.S.T.), still outstanding after the payment by the insurer.
15	Holdback	Where an amount of any payment has been retained by the Client as the holdback under relevant construction lien legislation, such amount will be paid to North American Concrete no later than 45 days after substantial performance of the scope of work set out in this offer.

16	Standard Exclusions	Unless otherwise stated in the Offer, the following are not included in the Offer: Permits; locating, disconnecting, capping, and/or relocating of existing utilities and services; removal of aboveground or underground tanks and cisterns; backfilling, compaction testing; grading; dewatering; consultant's
17	Adjacent Properties	Pre-inspection survey of the condition of neighbouring or adjacent properties is not included in the Offer. Unless otherwise stated in the Offer, shoring, underpinning, and/or damage protection of neighbouring or adjacent properties not included.
18	Underpinning, Repairs, Making Good of Structures	Unless otherwise stated in the Offer, underpinning of existing structures, as well as repairs and the making good of remaining structures and lands, are not included in the Offer. 22	Hidden Conditions	Should North American Concrete encounter unforeseen or undisclosed conditions once work is commenced that materially affect North American Concrete's scope of work and/or the completion of the project, North American Concrete will advise the Client. Such conditions include, but are not limited to, those hidden at the time of inspection or not referred to on drawings or in specifications. The cost of any extra work or expense required to address and/or remedy such conditions is not included in this Offer.
